Summarize the dangers of weapons and demonstrate how to seek help if a weapon or firearm is found.

Language Arts Objective 2.05

Draw conclusions, make generalizations, and gather support by referencing the text.

Materials Needed:

Drums of Noto Hanto by J. Alison James, Tsukushi Appendix 1 - transparency of Common Dangers of Weapons Appendix 2a, b - What Should You Do? scenarios

Focus:

Read The Drums of Noto Hanto by J. Alison James.

Ask the students: *What is a weapon?* Name some. (Something used to defeat or injure another, guns, knives, clubs)

What are some of the dangers weapons can bring or cause? (Death, slight or serious injury)

Can you defend yourself without the weapons mentioned earlier? How?

Ask the students to discuss what the people of Nabune, Japan, used as weapons.

Ask the students if that is better than using a more destructive weapon such as a gun and knife.

Teacher Input:

Display the common dangers of weapons overhead. Ask students what these dangers have in common? All of these dangers cause hurt or harm to people and things. These dangers are the reasons why weapons are regulated and why an adult should be notified immediately if a weapon is found. If anyone even suspects that another students is carrying a weapon or has seen a weapon, please notify your teacher or principal immediately.

America is losing too many children to gun violence. Between 1979 and 2001, gunfire killed 90,000 children and teens in America.

In one year, more children and teens died from gunfire than from cancer, pneumonia, influenza, asthma, and HIV/AIDS combined. (Children's Defense Fund)

Every day in America, 13 young people ages 19 and under are killed by guns. Gunshot wounds are the second leading cause of death for all people aged 10-34.

Share the following Gun Safety Rules with the class. If you see a gun even at home you may be tempted but DO NOT TOUCH IT!!! Leave the area and remember these rules:

- o Stop
- Don't touch

- Remove yourself from the area
- Tell an adult

Practice & Assessment:

Split the class up into pairs. Give each pair a scenario asking them to come up with a solution to the problem using the rules given earlier for dealing with a gun. (Appendix)
